## General Guidance for Certification

Pursuant to the USMCA and applicable US law, Certificates of Origin (CoO) must be preserved for record and reporting, and provided to CBP upon request. The USMCA and enabling US regulations permit that CoOs may be provided in various ways, including statements, invoices any other documents. Section 202 of the USMCA Implementation Act specifies the rules of origin (RoO) used to determine whether a good qualifies as an originating good under the Agreement. Additionally, the Harmonized Tariff System – US (HTSUS) also includes rules of origin, definitions, and other related provisions. In general, a good is originating when:

- A good is wholly obtained or produced entirely in a USMCA country;
- A good is produced entirely in the territory of one or more of the USMCA countries using non-originating materials provided the good satisfies all applicable requirements of product-specific rules of origin;
- A good is produced entirely in the territory of one or more of the USMCA countries exclusively from originating materials; or
- Except for a good provided for in HTSUS Chapter 61 to 63, the good is produced entirely in the territory of one or more of the USMCA countries, is classified with its materials or satisfies the “unassembled goods” requirement, and meets a regional value content threshold of not less than 60% if the transaction value method is used or not less than 50% if the net cost method is used (not including RVC for autos); and
- A good satisfies all other applicable origin requirements.

Wholly obtained goods. A good is originating in a USMCA country if the good is:

- a mineral good or other naturally occurring substance extracted from one or more of the USMCA countries;
- waste and scrap derived from production in one or more of the USMCA countries, or
- used goods collected in one or more of the USMCA countries, provided the goods are fit only for the recovery of raw materials; or
- a good produced in one or more of the USMCA countries, exclusively from a good meeting the other RoO requirements, or from their derivatives, at any stage of production.

Goods produced from non-originating materials. A good, produced entirely in the territory of one or more of the USMCA countries, is originating in a USMCA country if each of the non-originating materials used in the production of the good satisfies all applicable requirements of RoO rule.

Goods produced exclusively from originating materials. A good is originating in a USMCA country if the good is produced entirely in one or more of the USMCA countries exclusively from originating materials and the good satisfies all other applicable RoO rules.
